



Continuation of the share buyback program for a maximum amount of 800 million euros

On 14 February 2023, the Group announced the launch of a share buyback plan for €800m.

22.8 million shares were repurchased between February 27 and July 21, 2023, at an average price of €17.64, for a total amount of €400 million.

The Group announces today that it has signed a share buyback mandate with an investment service provider to continue the program. The new purchase period has begun on August 1st, 2023. The shares purchased will be held for future cancellation.
